**ORDER:**

The Director General of Police, Andhra Pradesh, Hyderabad, in his letter 4<sup>th</sup> read above, has stated that as per rules issued in G.Os 1<sup>st</sup> and 2<sup>nd</sup> read above, the constables of Armed Reserve and Special Armed Reserve will be eligible for transfer to Civil Police provided that they should possess the basic educational qualification prescribed for Civil Police Constables i.e., must have passed Intermediate or its equivalent examination recognized by the State Government. In the case of a candidates belonging to Scheduled Castes or Scheduled Tribes, they must have passed SSC or its equivalent examination recognized by the State Government and should have studied Intermediate and appeared for the Intermediate Examinations in both the 1<sup>st</sup> year and 2<sup>nd</sup> year as on the first day of July of the year in which they are considered for by transfer.

2. He has also informed that majority of Police Constables of Armed Reserve and Special Armed Reserve were appointed with the qualification of SSC and less standard, if the above qualification is prescribed, many Police Constables of Armed Reserve and Special Armed Reserve will loose their chance for appointment to the posts of Police Constables of Civil. He has, therefore, proposed to remove permanently the condition of education qualification.

3. He has further informed that only two conditions are there in Rule 7(a) regarding eligibility for appointment by promotion / transfer i.e., approved probationer and minimum service and it is applicable to all the posts in the Andhra Pradesh Police (Civil Police) Subordinate Service Rules. But, Rule 7(b) pertains to only appointment to the post of Police Constable (Civil) (Men) by transfer. Hence, to avoid confusion in the two conditions mentioned in Rule 7, he has proposed to shift rule 7(b) (After amending as above) to Note (1)(b) of Rule 3 and to issue an amendment with effect from 01.07.2005 as the matter regarding appointment to the post of Police Constable (Civil) (Men) by transfer is pending since 01.07.2005.

4. He has further informed that quotas are also revised for the post of Police Constable (Civil) (Men) in the Andhra Pradesh Police (Stipendiary Cadet Trainee) Rules in the amendment issued vide G.O. 3<sup>rd</sup> read above. Hence, to have equal and same quotas in both the Andhra Pradesh Police (Civil Police) Subordinate Service Rules and in the Andhra Pradesh Police (Stipendiary Cadet Trainee) Rules, he has proposed for an amendment to Note (1)(b) of Rule 3 of the G.O. 2<sup>nd</sup> read above, revising the quotas, with effect from 01.05.2006 i.e. from the date of issue of G.O. 3<sup>rd</sup> read above.

5. The Director General of Police, Andhra Pradesh, Hyderabad has therefore requested the Government;

- (1) to remove permanently the education qualification stipulated in rule 7(b) of G.O 1<sup>st</sup> read above, in respect of Police Constables of Armed Reserve and Special Armed Reserve for appointment by transfer.

- (2) to shift rule 7(b) (after amending as above) to Note (1)(b) of rule 3 of G.O 1<sup>st</sup> read above, to give amendment accordingly w.e.f 1.7.2005.
- (3) to issue amendment revising the quotas stipulated in rule note (1)(b) of rule 3 of G.O 1<sup>st</sup> read above, on par with the quotas as amended in G.O 3<sup>rd</sup> read above, and to issue amendment accordingly with effect from 1.5.2006 i.e. the dated of issue of G.O 3<sup>rd</sup> read above.

6. The Government, after careful consideration of the issue, hereby accept the proposal of the Director General of Police, Andhra Pradesh, Hyderabad as at para (5) above and decided to issue following amendments to the Andhra Pradesh Police (Civil Police) Sub-ordinate Service Rules.

7. Accordingly, the following notification will be published in the an extra ordinary issue of the Andhra Pradesh Gazette dated: 21.9.2010

### **NOTIFICATION**

In exercise of the powers conferred by Sections 8 and 10 of the Andhra Pradesh (Andhra Area) District Police Act, 1859 (Act XXIV of 1859) Sections 6 and 10 of the Andhra Pradesh (Telangana Area) District Police Act (Hyderabad X of 1329 F) and section 5 read with section 6,7 and 12 of the Hyderabad City Police Act (Hyderabad Act IX of 1348 F) read with the proviso to article 309 of the Constitution of India and of all other powers hereunto enabling, the Governor of Andhra Pradesh hereby makes the following amendments to the Andhra Pradesh Police (Civil Police) Subordinate Service Rules issued in G.O.Ms.No.374 Home (Pol.C) Dept., dated: 14.12.1999 and as amended from time to time.

The amendment-I shall be deemed to have come into force with effect from the 1<sup>st</sup> May, 2006.

### **AMENDMENT - I**

I. In the said rules, in rule 3, in Note (1) under Sub-heading "(b) Police Constables (Civil)", for the existing entries the following entries shall be substituted, namely:-

(i) Direct Recruitment	71%
(ii) HG	8%
(iii) MSP	2%
(iv) CPP	4%
(v) CDI	2%
(vi) NCC	3%
(vii) Appointment by transfer from Armed Reserve / Special Armed Reserve Central Police Line Police Constables	10%

**Explanation - I:** The definition and eligibility (Criteria) of the categories "HG, MSP, CPP, CDI and NCC" shall apply the provisions of the Andhra Pradesh Police (Stipendiary Cadet Trainee) Rules issued in G.O.Ms.No.315 Home (Pol.C) Department dated: 13.10.1999 and the amendments thereon.

The amendment-II shall be deemed to have come into force with effect from the 1<sup>st</sup> July 2005.

**AMENDMENT - II**

"In the said rules-I, in Rule 3, after Explanation I to Note (1)(b), the following shall be added, namely:-

**Explanation – II:** The Police Constables (AR) (Men) and Police Constables (SAR CPL) (Men) will be eligible for transfer to Police Constables (Civil) (Men) provided that

- (i) they are approved probationers;
- (ii) they have served in the AR/ SAR CPL for not less than five years of the service on the first day of July of the year in which they are considered for transfer.
- (ii) They have completed the age of forty (40) years on the first day of July of the year in which they are considered for transfer.
- (iii) they have not come under any for the following categories
  - (a) Any major punishment in the entire service
  - (b) Minor punishments – three or more in the entire service
  - (c) Any punishment under operation
  - (d) Under suspension or facing an oral enquiry

**Selection Procedure:**

- (i) The vacancies of 10% of Police Constables (Civil) (Men) shall be filled with local candidates only. The vacancies if any out of 10% of Police Constables (Civil) (Men) which remain unfilled for want of eligible candidates will be added to the vacancies to be filled by direct recruitment.
- (ii) Order of selection in the preparation of the list: In each category, length of service in Armed Reserve / Special Armed Reserve will be taken into account and wherever the length of service in Armed Reserve / Special Armed Reserve is the same, then the date of birth of the candidate will taken into account i.e., the older person will be preferred".

II. for rule 7, the following shall be substituted, namely:-

"7. Minimum Service: No person shall be eligible for appointment by promotion unless he/she is an approved probationer and has put in not less than five years of service in the category from which promotion is made".
