3. The seniority list of PC (AR) who are local to Guntur district and submitted willingness for conversion to PC(Civil) from the various units is sent herewith for information.

He is also requested to issue appointment orders as Police Constables (Civil) (Men) **with effect from 16-09-2017** for the Police Constables (AR) (Men) / Police Constables (SAR CPL) (Men) **mentioned in para 1 above** and **selected to their unit** and they should be sent to undergo training only after receipt of allotment of Training Institution from IGP, Training, A.P.
