PRESS RELEASE

Recruitment to the posts of SCT Police Constable (Civil) (Men & Women), SCT Police Constable (AR) (Men & Women), SCT Police Constable (APSP) (Men) in Police Department and Warder (Men) & Warder (Women) in Prisons & Correctional Services Department and Firemen (Men) in A.P. Fire & Emergency Services Department was notified vide Notification Rc.No.215/R&T/Rect.2/2018, Dtd:12-11-2018.

2. Preliminary Written Test (Qualifying test) for the above posts was conducted on 06.01.2019 & 08.01.2019 at 28 locations/704 Centres in Andhra Pradesh. **3,51,860** candidates participated in the exam out of which **1,09,106** candidates qualified. The result is available on the website "slprb.ap.gov.in". The break-up of candidates who appeared and qualified, gender-wise, caste-wise and Regional centre wise is furnished below:-

3. All the candidates are once again informed that the qualifying marks are as follows:

**OC:** 40% in Paper (i.e., 80 Marks out of 200);

**BC:** 35% in Paper (i.e., 70 Marks out of 200)

**SC, ST and Ex-Servicemen:** 30% in Paper (i.e. 60 Marks out of 200).

The result for Preliminary Written Test has been prepared accordingly. It is observed that community mentioned by some candidates in application form and OMR Sheet is not matching. The benefit of doubt is given to the candidates in all such cases in preparing the result. However, this result will be subject to the actual community certificate produced by the candidate at the time of PMT/PET.

4. With regard to the answer key released on 08.01.2019 after the examination, more than 145 objections were received. The subject experts looked into all these objections. In respect of the following 2 Questions in the Paper Set (P2), all the candidates who either answered or didn't answer were given 1 Mark each, in order to extend benefit of doubt to the candidates. In respect of Paper Set (P1), there are no changes in Preliminary Key. As it is only a qualifying examination and the marks secured therein by the candidates do not have any impact on their Final Merit, no candidates is affected adversely.

5. The Scanned OMR Sheets will be available for download for **three** days from **22.01.2019 Afternoon**. Any candidate who desires his OMR Sheet to be "verified" may apply online by downloading his scanned OMR Sheet and making payment of Rs. 1,000/- (Rupees one thousand only) for paper through online and submit his

request for "verification" on website "slprb.ap.gov.in" from 23.01.2019 at 11.00 AM to 25.01.2019 at 05.00 PM in the following format:

6. It is reiterated that the candidate should submit his requests for verification separately for paper and **not** through one common payment combining two or more requests. Otherwise, first request alone will be considered and others will be summarily rejected.
