

**PRESS RELEASE**

Recruitment to the posts of SCT Police Constable (Civil) (Men & Women)- 3216 Posts, SCT Police Constable (AR) (Men & Women)- 1067 Posts, in Police Department and Warders (Male)-240 Posts & Warders (Female)- 25 Posts, in Prisons & Correctional Services Department was notified vide Notification Rc.No.202/R&T/Rect.2/2016, dt: 22-07-2016. The Physical Measurement Test, Physical Efficiency Test & Verification of Certificates was conducted from 01-12-2016 to 31.12.2016 at all 13 District Headquarters in a phased manner for the above posts for those candidates who qualified in the Preliminary Written Examination held on 6-11-2016.

2. The following candidates attended the PMT/PET and qualified:

- a) No. of candidates qualified in Preliminary Written Test- 1,16,142.
- b) No. of candidates attended for PMT/PET/Verification of Certificates- 1,00,833.
- c) No. of candidates absent in the PMT/PET- 15,309.
- b) No. of candidates qualified in PMT/PET/Verification of Certificates- 72,227

3. The result of Preliminary Written Test was declared based on information submitted by candidates without any verification. There are 17 candidates who applied for the said posts under category of Ex-Servicemen and attended Physical Measurement Test(PMT)/Physical Efficiency Test(PET) in the category of Ex-Servicemen. However, these candidates did not submit the Ex-servicemen Certificates at the time of Physical Measurement Test (PMT)/Physical Efficiency Test (PET) Centres. Hence, as per their performance in Physical Efficiency Test (PET), they are disqualified for Final Written Test to be held on 22-01-2017.

4. Further, 7 candidates whose Physical Measurement Test data was not matching with result data have been sent for appeal on 12-1-2017. As per the result of PMT, their hall tickets will be made available on 17-01-2017.

5. Also, as per the orders of Hon'ble APAT, 127 candidates have been directed to attend for the Physical Measurement Test (PMT)/Physical Efficiency Test(PET)/Verification of Certificates at 4 locations i.e., at Visakhapatnam, Eluru, Guntur & Kurnool on 11-1-2017 & 12-1-2017. These candidates who appeared on the above dates for PMT/PET/Verification of Certificates on the above Centres, as per their result, their hall tickets will be made available on 17-01-2017.

6. The Final Written Examination for the said posts will be held on 22.01.2017. Examination for One Paper (i.e. Objective Type Paper) in which all candidates have to appear will be conducted on 22.01.2017 from **10.00 AM to 01.00 PM**. The said Examination will be held in **5** locations i.e. Visakhapatnam, Rajamahendravaramu, Vijayawada, Tirupati and Kurnool:-

(i) Candidates who appeared in Physical Measurement Test(PMT)/Physical Efficiency Test(PET) at Srikakulam, Vizianagaram & Visakhapatnam will be allotted Test Centre at Visakhapatnam.

(ii) Candidates who appeared in Physical Measurement Test(PMT)/Physical Efficiency Test(PET) at Kakinada & Eluru will be allotted Test Centre at Rajamahendravaramu.

(iii) Candidates who appeared in Physical Measurement Test(PMT)/Physical Efficiency Test(PET) at Machilipatnam & Guntur will be allotted Test Centre at Vijayawada.

(iv) Candidates who appeared in Physical Measurement Test(PMT)/Physical Efficiency Test(PET) at Ongole, Nellore & Chittoor will be allotted Test Centre at Tirupati.

(v) Candidates who appeared in Physical Measurement Test(PMT)/Physical Efficiency Test(PET) at Kadapa, Anantapur & Kurnool will be allotted Test Centre at Kurnool.

7. The List of candidates who qualified in Physical Measurements Test (PMT) & Physical Efficiency Test (PET) for the post of SCT Police Constable (Civil) (Men & Women), SCT Police Constable (AR) (Men & Women), in Police Department and Warders (Male) & Warders (Female) in Prisons & Correctional Services Department and are eligible to appear in Final Written Examination is available on the Website – Unit wise.
